**1. General provisions**

- 1.1 Student organization "Unihood" is a on the student government of the I. K. Akhunbaeva Kyrgyz state medical Academy (the "KSMA"), which is created in order ensuring the rights of students to participate in the management of educational process, the solution of important questions of life students, the development of its social activity, support and the implementation of social initiatives.
- 1.2 The student organization "Unihood" carries out its activities in accordance with the current legislation of the Kyrgyz Republic, acts of the Ministry of Education and Science of the Kyrgyz Republic and the Ministry of Health of the Kyrgyz Republic, the charter of the KSMA, and this Regulation.
- 1.3 The student organization "Unihood"("Unihood") is formed from among the full-time students of KSMA.
- 1.4 Every student of KSMA has the right to join the student organization "Unihood".
- 1.5 The activities of the student organization "Unihood" are aimed at all students of KSMA.

**2. Main goals and areas of work**

- 2.1. "Unihood is a student organization with the co-operation of the public Association "Luciana Malan", Department of educational organizational and mass work of KSMA, Vice-rector for the state language and educational work by B. K. Irysova, Vice-rector for international relations and strategic development of KSMA G. A. Jumalieva main goal is the implementation of the projects aimed at the qualitative and quantitative improvement in the lives of students KSMA, as well as raising the potential and academic performance students of KSMA in cooperation with the administration of KSMA, other Universities, sponsors, partners, and individuals. The main areas of work of "Unihood "are:
- I. Implementation of projects aimed at medical students;
  - II. Involvement of the active part of KSMA students in joint educational work, provision of conditions for the spiritual, physical, and intellectual development of

students, assistance in the implementation of vital issues of the organization of training and self-development;

III. Organization of the project "Mentoring", in which the following events are held: "Orientation program" and "Mentor program".

### **3.Rights and obligations**

3.1 The student organization "Unihood" has the right to:

- I. Take a direct part in the planning, preparation, conduct and analysis of extracurricular activities of KSMA;
- II. Participate in the work of the communities created in the KSMA on issues related to the social activities of the KSMA.

3.2 The student organization "Unihood" is obliged to:

- I. Carry out work in accordance with the regulations and the plan of activity of the student communities of KSMA for the academic year;
- II. Support socially significant initiatives of KSMA students;
- III. Inform the KSMA management bodies about their activities

### **4.Composition and organizational structure**

4.1 The composition of the general meeting of the student organization "Unihood" includes:

- I. Leaders of "Unihood"
- II. Volunteers/students of KSMA.

4.2 General Meetings of Unihood are held as necessary, but at least once a month.

4.3 The student organization "Unihood" acts on a permanent basis, implements the goals and objectives of the student community, outlined in this Regulation.

4.4 Leaders of the student organization "Unihood"

- I. Plan activities and organize events in the following areas: within the relevant area of work;
- II. They make proposals for the development of student self-government in KSMA and conduct relevant events;
- III. Strictly perform their duties outside of school hours.

### **5.Ensuring the activities of the student organization "Unihood"**

5.1 The management bodies and administration of the KSMA provide the funds necessary to support the activities of the organization "Unihood". At the same time, the student organization "Unihood" has the right to attract personal non-financial and financial resources of the members of the organization "Unihood", students of KSMA, sponsors, partners, and individuals.

5.2 To ensure the activities of the organization "Unihood" the management bodies and the administration of the KSMA provide premises (assembly hall, offices),

communication facilities for free temporary use, KSMA office equipment and other necessary materials, tools and equipment.

## **6. Creation and liquidation of the student organization "Unihood"**

6.1 The question of the creation and liquidation of the student organization "Unihood" is accepted only at the General Meeting of the members of the organization "Unihood".

## **7. Introduction of amendments and additions to this Regulation**

7.1 As necessary, this Regulation may be amended by a unanimous decision of the General Meeting of "Unihood".

## **8. The order of decision-making among the leaders**

8.1 Decision-making procedure-decisions will be made by a majority.
